1. Feedback from the PIs of JRAs and NAs to the evaluation report

On August 17, 2010 all PIs of JRA and NA proposals received the evaluation sheet with recommendations for a full proposal. The final selection of the JRAs for the RadioNet3 proposal will be done by the Coordinator based on the full proposals submitted by September 15, 2010.

Up to now it was mentioned that the JRAs Readiness and Madera will not resubmit an own proposal but seek collaborations with the JRA POPS.

As several questions came up with regard to the formal structure of the full proposal, all PIs received the required information and excel sheets for the financial calculations.

No other feedback was received.

2. TNA selection process

The TNA call for proposals was published on August 2, 2010 with a deadline on September 15, 2010. The selection committee will consist of all directors of the radio observatories involved in RadioNet2 and Simon Garrington as advisor.

3. Timetable of the Proposal writing

VT summarised the structure of the proposal and distribution of the tasks within the team. AZ, HvL and FM are going to write the section 1 "Scientific and technical quality", meanwhile VT and IR are going to draft the section 2 to 5.

After the deadline for full proposals of JRA and NA on September 15, 2010 and the final decision on the JRAs, Section 1 will be updated with the missing aspects resulting out of the scientific and technical part of the Work Packages (WP). IR and VT will draft the GANTT diagram, the deliverables and the resources table.

The first draft of the proposal shall be ready by October 6, 2010 and will be distributed to the members of the Critical Review Team (CRT). The review meeting will take place on October 13, 2010 in Valencia (ES).
