HW acceptance

No specific questions/comments - skipped.

SW acceptance

- Cycle 4 SW is basically completed.
- Modified manual mode observing script could go in SSR, but it is not there yet; should demonstrate in the next few weeks. Priority tickets are: ICT-5575, ICT-325, ICT-3954. Target is to include at 2015.8.
- ICT-3812 and ICT-4449: need to be addressed together with NRAO Computing, target is to include the fix at 2015.8.
- 2015.8 would be delivered to release managers on Dec. 16th, delivered to Ops during February shutdown.
- E2E? tests would start from OT, schedule the observation, execute, reduce data; i.e, the full cycle. Proposed to keep separate from the general ALMA SW E2E? tests.
- Sub-arrays and APP interaction issue: considering that a maximum number of antennae is desired for VLBI observations the impact should be low.

Commissioning

- Requirements summary: all satisfied except two (section 5.6 of the summary).
- Requirement APP150 phasing efficiency: technical problems caused corrupted VLBI data, used all data for phasing efficiency.
 Would be an asset to take more phasing data in order to confirm that specifications are met.
- Polconvert: not part of the APP ALMA SW, part of post-processing (post-correlation).
- Data correlation and reduction SW is not a deliverable, though the ALMA VLBI working group is aiming at defining the policy for VLBI observations, what kind of data will be stored in the Archive, etc.
- Commissioning priorities:
 - o Acquire more ALMA phasing data, exercising observing conditions, phasing efficiency, could be done remotely.
 - One more VLBI commissioning campaign: still need tests will a fully-phases array, need a few longer observations.

Tentative timeline

- APP SW development (priority items) by mid December (for 2015.8)
- SW verification during Dec/Jan
- Campaign for combined E2E? tests (SW) and pending Commissioning around March-April, schedule TBC with ALMA JOT
- APP SW acceptance part of Cycle 4 SW Acceptance later in 2016 (according to the established timeline)
- System verification & Commissioning results review part of the Final Acceptance (after SW acceptance and before the start of Cycle 4 - TBC with ALMA JOT)
